2000

The Company lost an intellectual property lawsuit against FMC in the United States and was on the verge of bankruptcy.

The Company reorganized the board of directors and management appointing Zheng Zuhua as the General Manager.

2002

Acquired a major Cargo Handling System project, as the prime contractor from China Southern Airlines at the new airport in Guangzhou; which happened to be the second largest airport in the world at that time. This major project rewrites the record for the largest awarded single contract amount of its time.

The first roadway stacker parking garage project at Beijing Tuan Jie Hu apartment that was delivered and used. This garage became the demonstration project by the Beijing Municipal Science and

Technology Commission to showcase the advanced technology level adopted by the venture.


